

# **Privacy Policy**

Future Diagnostics Solutions B.V. understands and respects the importance of your privacy. This Privacy Policy describes how your personal data is collected, used, and shared according to the General Data Protection Regulation (GDPR), when you interact with us or when you visit www.future-diagnostics.com (the "Site"). By 'personal data' we mean any personally identifiable information.

#### Personal data we collect

When you interact with us, we may ask you to supply us with personal data. We will only process your personal data in ways that are compatible with the purposes described in this Privacy Policy. Personal data we collect when you interact with us are your company information and address, name, title, e-mail address and telephone number. When you visit the Site, we automatically collect certain information about your device, including information about your web browser, IP address, time zone, and some of the cookies that are installed on your device. Additionally, as you browse the Site, we collect information about the individual web pages or products that you view, what websites or search terms referred you to the Site, and information about how you interact with the Site. We refer to this automatically-collected information as "Device Information." We collect Device Information using the following technologies:

- "Cookies" are data files that are placed on your device or computer and often include an anonymous unique identifier.
- "Log files" track actions occurring on the Site, and collect data including your IP address, browser type, Internet service provider, referring/exit pages, and date/time stamps.
- "Web beacons," "tags," and "pixels" are electronic files used to record information about how you browse the Site.

## Why we collect personal data

We collect personal data for managing our customer relationship with you. In the majority of cases, we receive the personal data from you directly, for example when you request additional information about our services from us. We use such data for the following purposes:

To provide you the services and products you requested from us. This includes taking your order, delivering your order and processing invoices relating to that order. Where necessary, we also use your personal data for collecting overdue payments from you. All these actions result from the contract we have with you and they are necessary for fulfilling

our obligations arising from our customer relationship with you.

To answer your questions about our services or products or other requests.

To send you invitations to our events maintaining our customer relationship with you. You always have the right to opt-out from such communication.

In order to ensure that we process accurate information about you we use the services of external service providers to supplement the information you have provided to us and keep it up-to-date.

We also collect data about you when you use our services, in order to meet your specific needs or wishes.

## Suppliers, and other important stakeholders

We collect personal information of our suppliers' contact persons and about external service providers. We collect information also from other important stakeholders that are otherwise regarded important to our business. The information is collected from the person him/herself, from their employer or from public sources. We use the data for the following purposes:

to manage the relationship between these stakeholders

to communicate with our suppliers and other important stakeholders

to be able to assess the fulfillment of defined requirements

to manage and provide work orders

we perform background screenings about our suppliers to check that the company is for example ISO certified.

#### How do we use your personal data?

We use the Device Information that we collect to improve and optimize our Site (for example, by generating analytics about how our customers browse and interact with the Site, and to assess the success of our sales, marketing and advertising campaigns).
